## Objective

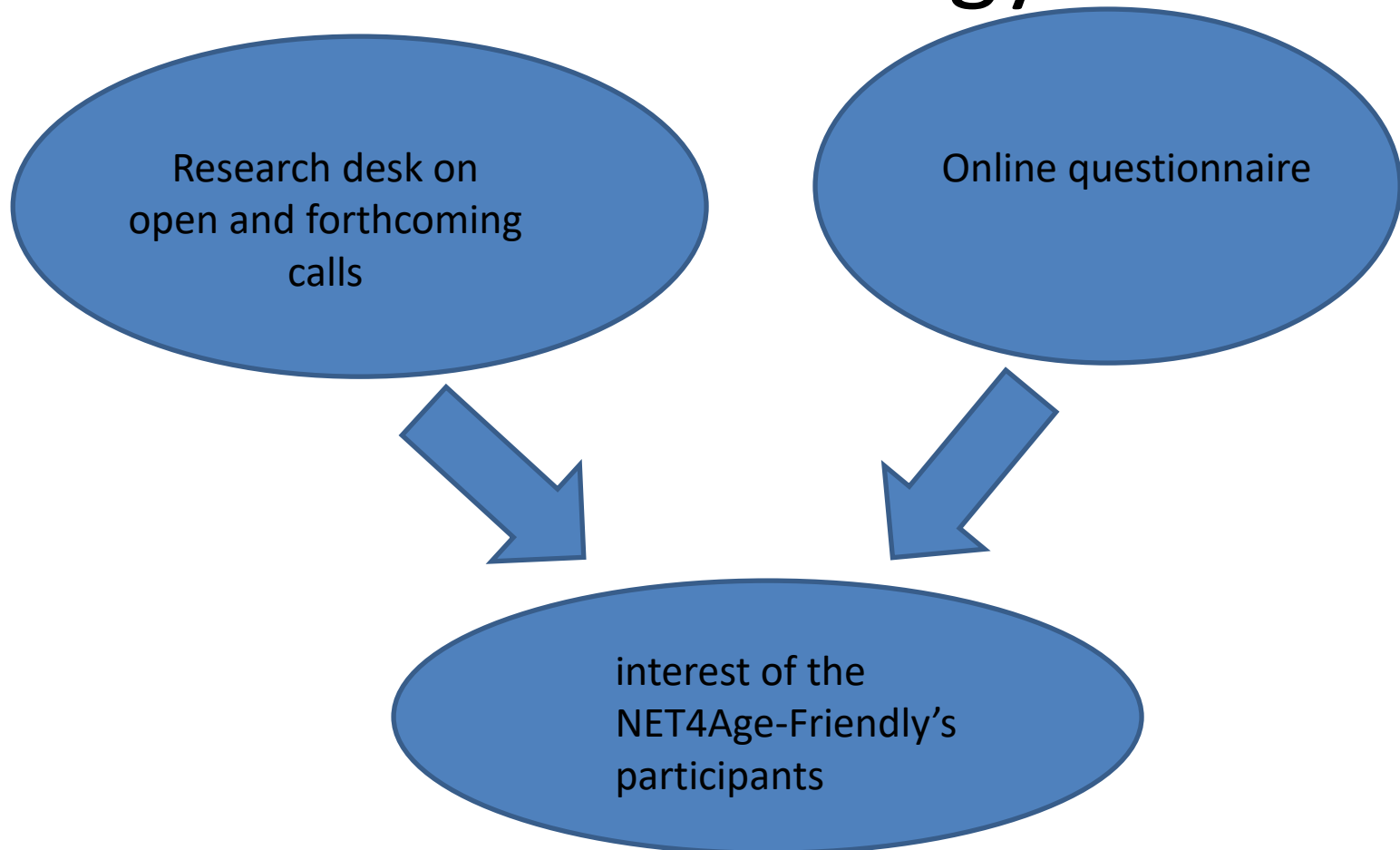

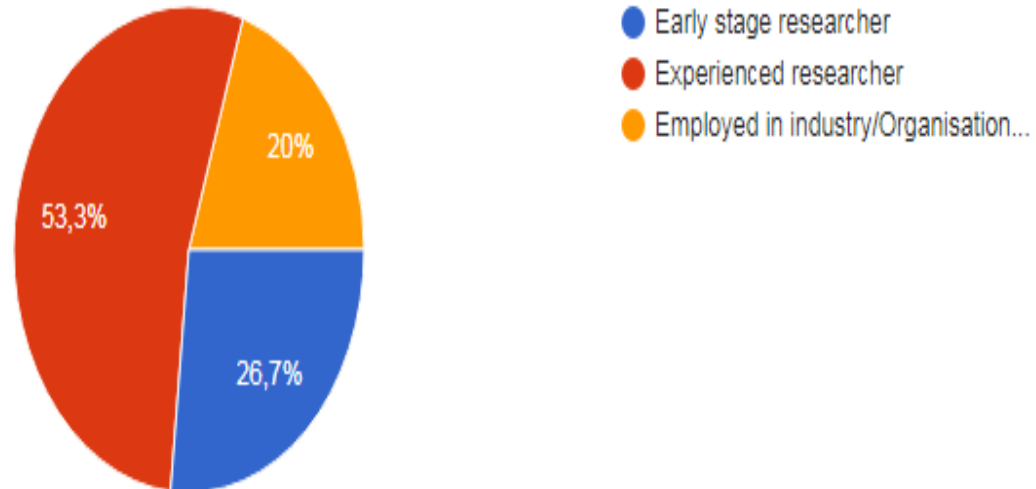

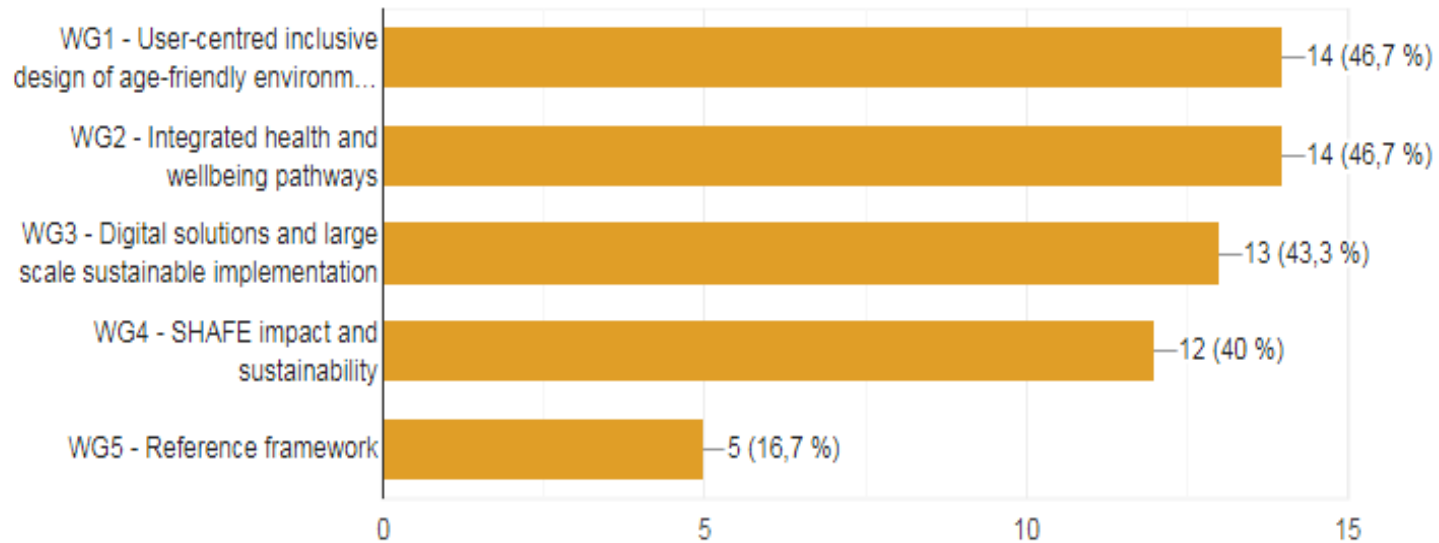

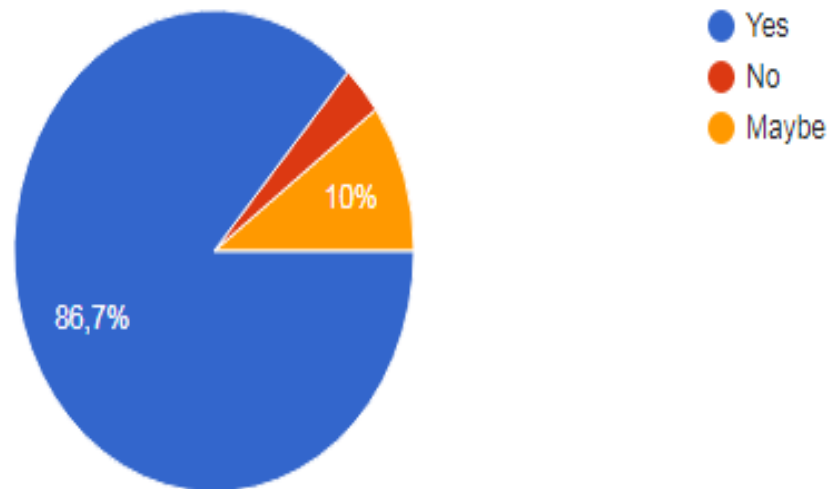

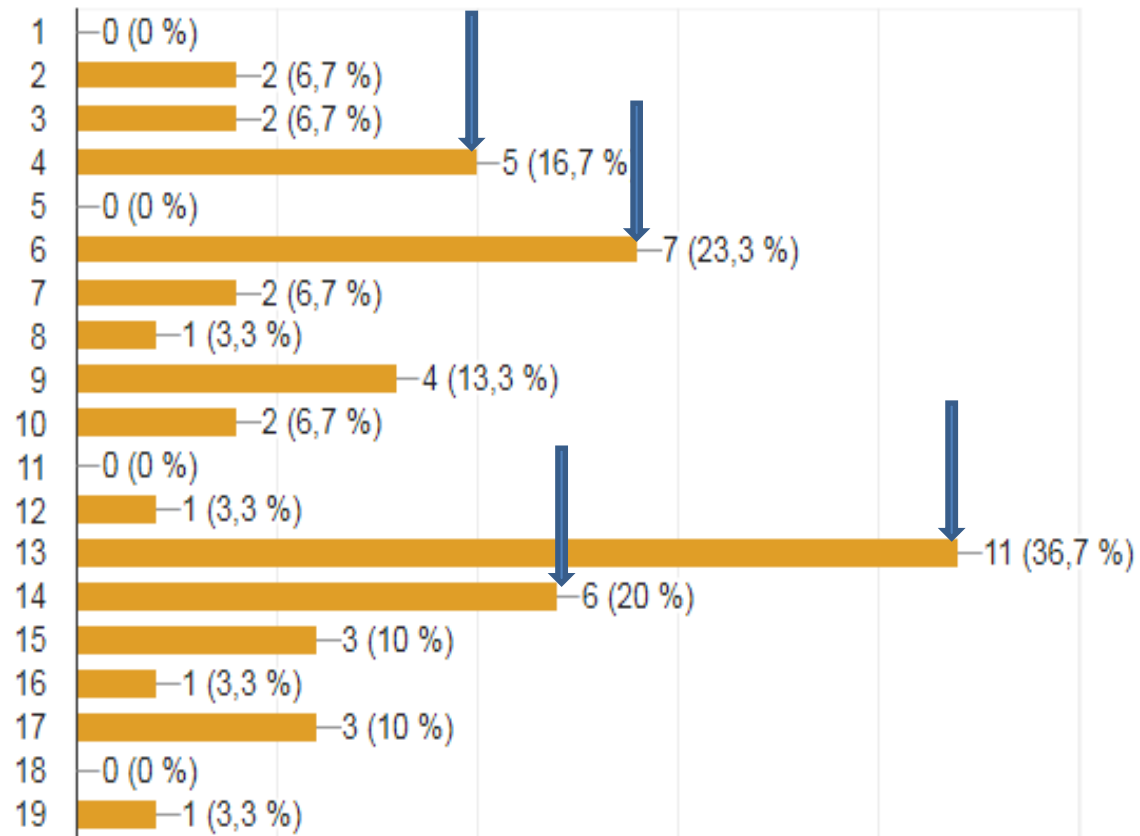

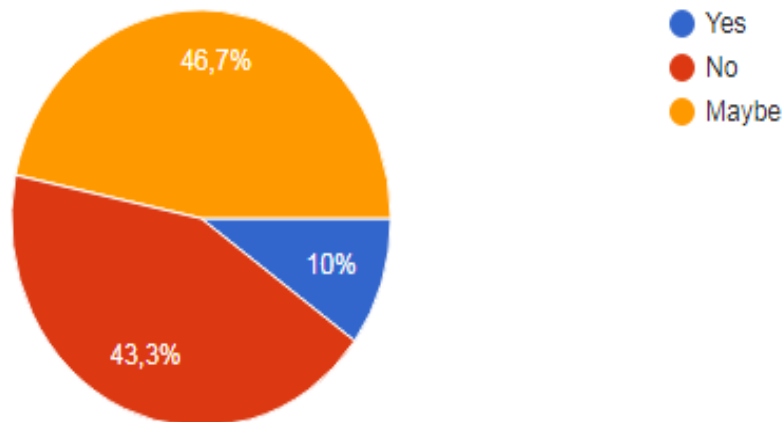

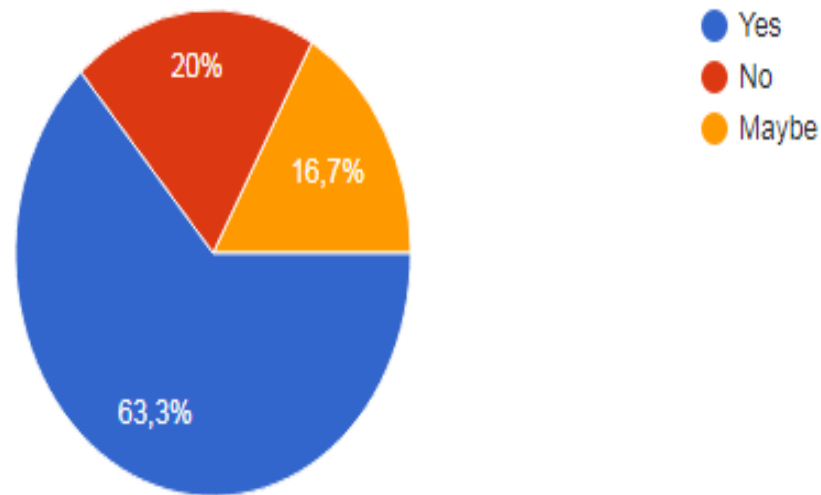

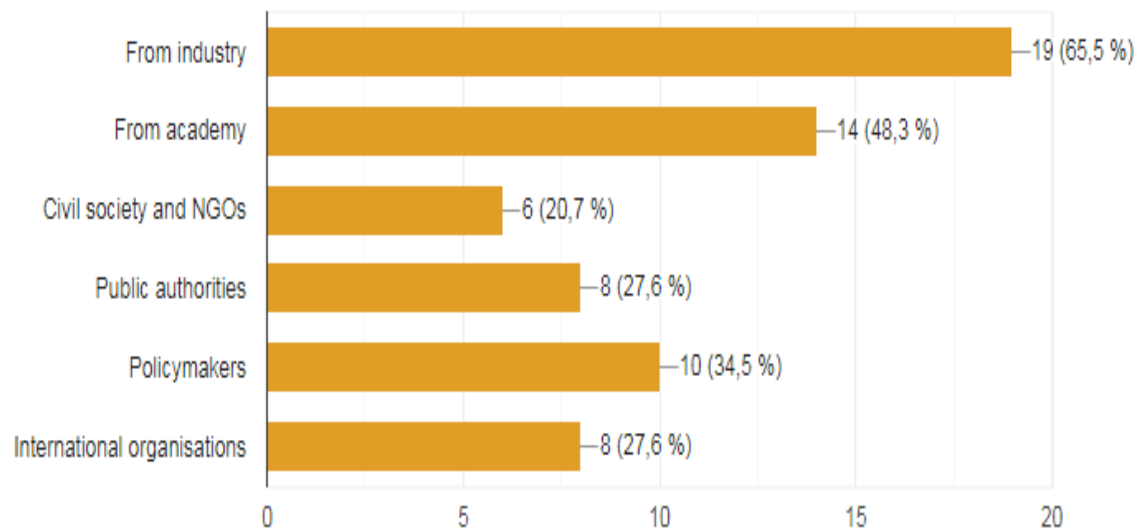

What kind of partner do you need?

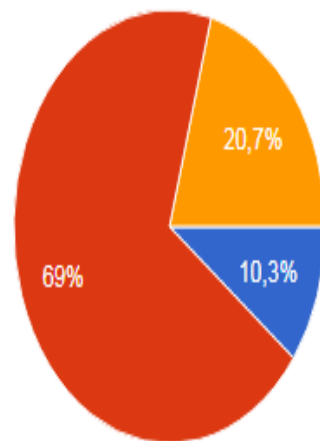

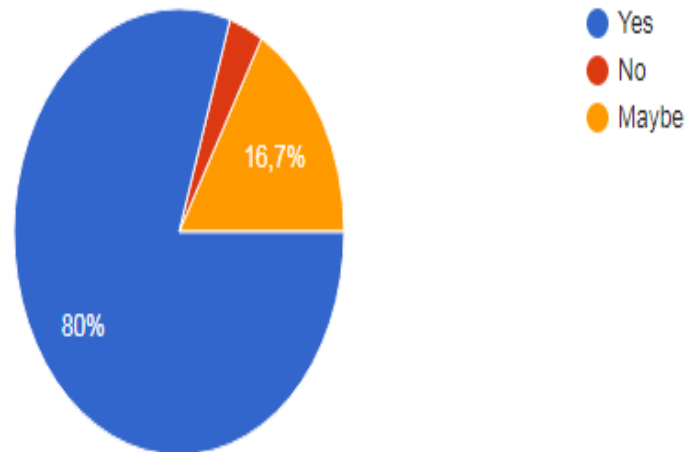

They noticed that network improvement need to be in:

- Visibility and awareness
- Clarity about ways of collaboration
- Activate the group members, send out questionnaires that they have to fill out and share knowledge with others
- exchange of content developed between the different working groups
- More face to face meetings, During a physical meeting, it would help to arrange a session where partners can briefly explain what they do and potential ideas and use the survey for matchmaking
