In Part one held from 7 to 8 PM (CET) we presented our research on "Women, Family and Careers -Work / Life Balance in the V4 Countries" conducted between October 2021 and February 2022. One of our partner in this research was the Krakow University, and their professor talked about the scientific and human aspects of their qualitative research.

We are pleased that for the second time we had the opportunity to bring a "Visegrad" project to this this Forum. On this occasion we introduced the representative of the International Visegrad Fund. This Fund provides the financial background for implementing our ideas and dreams born in the 4 Visegrad countries.

As one of the few NGOs coming from our region, we always look to adopt positive foreign best practices to bring home. Needless to say, at the same time we are proud to present our exemplary Hungarian practices.

Therefore, we are pleased that the managing director of the Family Friendly Hungary Center presented those Hungarian measures that are almost unique in the world which effect Hungarian women and families, especially with regard to dealing with Covid.

In the second Part of our event from 8 to 9 PM (CET) we presented our Programs dedicated to the UN Decade of Healthy Ageing.

We have been working for 55+ women within the frameworks of our "Women's Career for a Lifetime" program since 2009. We would like to contribute to the goals of the Decade of Healthy Ageing in several fields, which are participation in the labor market and LLL, role of the media, and age-friendly environment including climate change and ageism.

As local representative and part of the INPEA network I thank the president who came to talk about their worldwide activities in prevention of elder abuse and pursuit of a new convention on the human rights of older persons.

We are pleased that we had with us the initiator of the COST (European Action -COST European Cooperation in Science and Technology) Action on Smart Healthy Age-Friendly Environments which received recognition in the UN as best practice. We are also a member of this alliance. We included the presentation of our media expert also this time because we cannot neglect the huge influence of the media.

Our last presentation gave an insight into our approach regarding 50+ Women and digitalization. We are happy that we could share some best practices from Hungary helping this age group to keep up with the fast moving of this area.
